## TERMS & CONDITIONS

### JOINING FEES

Berthing Fee rates are based upon berth size or vessel size, whichever is greater.

Joining fee is a one time fee payable at joining, it is non refundable and non transferable.

One adult yacht club membership included, additional memberships are available for purchase.

Benefits are only valid in line with the valid berthing agreement.

Utility consumption (power and water) is metered and charged separately on a quarterly basis, as per DEWA tariffs and service charges.

### PAYMENT TERMS

Payment must be made in full prior to commencement of berthing with the following options:

- \* Cash or one cheque
- \* Wire transfers (charges covered by sender)
- \* Late payments may be subject to penalty charges
- \* Credit card
- \* One current dated cheque and two (2) PDCs

### POST DATED CHEQUE FEES

Post dated cheques are accepted within the club, however a 5% additional surcharge will be applied on the annual berthing fee rate.

### EARLY BERTHING DISCOUNT

This 'Early Berthing' discount can only be availed upon completion of the first year berthing agreement.

Payment must be received at least 30 days prior to commencement date of the berthing agreement.

Full payment is required by cash, cheque, credit card or bank transfer.

All berthing contracts must be signed by the berth holder or else the offer will not be valid.

Payments made by cheque must be dated at least 30 days prior or more to the commencement date of the berthing agreement.

Bank transfers must be received to BMYC at least 30 days prior to the commencement of the berthing agreement in order to qualify.

Contracts terminated early or transferred to another customer prior to the contracted end date will forfeit the discount amount at the time of settlement.

### SECURITY DEPOSIT

A refundable security deposit equivalent to two months of berthing fees is required for every berth engaged.

This will be refunded to you on termination of the contract minus any outstanding and unpaid fees.

### CONDITIONS AND RESTRICTIONS

All rates, charges and fees are subject to change at BMYC's discretion.

Management reserves the right to decline vessels based on size for a particular berth.

Boat size is calculated on the FTA/DMCA official registration of the vessel.

Contract start date is based on day of reservation regardless of if the vessel occupies the berth at a later date.

Purchasing an existing private boat and converting it to a charter/commercial is strictly prohibited.

Any attempts in converting a boat will result in the berthing agreement being void and immediate removal of the boat.

A visitor berthing fee charges will apply for the duration of the stay.

All rates are quoted in AED.

### DOCUMENTS REQUIRED

All vessels are subject to review and approval by BMYC management prior to receiving the berthing agreement.

1. Valid passport and residence visa
2. Boat registration
3. Boat insurance
4. Valid Emirates ID
5. Boat driving license
