TERMS & CONDITIONS

JOINING FEES

Berthing fees calculated based on berth size or overall vessel length, whichever is greater.

Joining fee payable upon joining. Fee is non-refundable and non-transferable.

Membership includes two adults and two children. Yacht Club membership included. Additional memberships available for purchase. Benefits valid only in line with the applicable berthing agreement.

Utility consumption (power and water) metered and charged separately on a quarterly basis, in accordance with DEWA tariffs and applicable service charges.

Refundable security deposit applicable.

PAYMENT TERMS

Payment to be made in full prior to the commencement of berthing. Accepted payment methods as follows:

- Cash or single cheque
- Wire transfer (charges to be covered by the sender)
- Credit card
- One current-dated cheque and three (3) post-dated cheques (PDCs)

Late payments may be subject to penalty charges.

Post-dated cheques accepted. A 5% surcharge applies to the annual berthing fee.

EARLY BERTHING DISCOUNT

Early Berthing discount applicable upon completion of the first-year berthing agreement.

Payment to be received at least 30 days prior to the commencement date of the berthing agreement.

Full payment required by cash, cheque, credit card, or bank transfer.

All berthing contracts must be signed by the berth holder to qualify.

Cheque payments must be dated at least 30 days prior to the commencement date.

Bank transfers must be received at least 30 days prior to the commencement date.

Early termination or transfer of the contract prior to the agreed end date will result in forfeiture of the discount at settlement.

SECURITY DEPOSIT

Refundable security deposit equivalent to two months of berthing fees required for each berth. Deposit refundable upon termination of the contract, less any outstanding or unpaid fees.

CONDITIONS AND RESTRICTIONS

All rates, charges, and fees subject to change at Bvlgari Yacht Club Dubai's discretion.

Management reserves the right to decline vessels based on size and berth suitability.

Vessel size determined by overall length.

Contract start date based on the date of reservation, irrespective of the date the vessel occupies the berth.

Conversion of privately owned vessels for charter or commercial use strictly prohibited.

Any attempt to convert a vessel will result in immediate termination of the berthing agreement and removal of the vessel.

Visitor berthing fees apply for the duration of the stay.

All fees are quoted in AED.

DOCUMENTS REQUIRED

All vessels subject to review and approval by BMYC management prior to issuance of the berthing agreement.

1. Valid passport and residence visa
2. Boat registration
3. Boat insurance
4. Valid Emirates ID
5. Valid boat driving licence

*All prices are in AED inclusive of 10% service charge, 7% municipality fees and 5% VAT
